### BOOKING TIMES

ALL MAKEUP AND HAIR APPOINTMENTS MUST BE AT THE SAME LOCATION AND IN CONSECUTIVE ORDER (NO GAPS IN BETWEEN)

### DELAYS

CLIENT TARDINESS IS CONSIDERED A NO SHOW. THE BRIDE IS PRIORITY AND TIMING IS CRUCIAL. IF TIME PERMITS I WILL TRY TO ACCOMMODATE THE PERSON(S) TARDY .

LATE FEES APPLY.

### *ONSITE / TRAVEL FEES*

TRAVEL ON LOCATION IS AN ADDITIONAL CHARGE BY MILEAGE.

VALET, TOLLS AND/OR HOTEL ACCOMMODATIONS APPLY.

### TRIALS

A TRIAL IS A PRE-WEDDING MAKEUP APPLICATION OR HAIR APPOINTMENT WITH YOUR MAKEUP ARTIST OR STYLIST BEFORE YOUR WEDDING TO DETERMINE COLORS, ETC. AND TO MAKE SURE YOU LOVE YOUR LOOK. IF YOU ARE NOT SATISFIED WITH YOUR MAKEUP OR HAIR AT THE TIME OF TRIAL, **YOU MUST TELL YOUR ARTIST AT THE TIME OF THE TRIAL** SO THAT SHE CAN MAKE ANY ADJUSTMENTS NECESSARY DURING YOUR APPOINTMENT. INCLUDES ONLY ONE 1-2 HOUR RUN-THROUGH.

**IF YOU WISH TO TRY ANOTHER LOOK, YOU WILL NEED TO MAKE AN ADDITIONAL APPOINTMENT FOR THE SERVICE PROVIDED, UNLESS ANOTHER AGREEMENT IS DISCUSSED.**

TIP: IF ANYONE IN BRIDAL PARTY IS REQUESTING A TRIAL CONSIDER HAVING IT ON THE SAME DAY TO SAVE AN ADDITIONAL TRAVEL FEE

## **PAYMENT**

FINAL PAYMENT FOR BRIDE AND ALL SERVICES BOOKED MUST BE PAID IN FULL BEFORE SERVICES. THE BRIDE AND/OR RESPONSIBLE PARTY ARE RESPONSIBLE FOR PAYMENT FOR THE ENTIRE BRIDAL PARTY BOOKED. ALL DEPOSITS PAID ARE NON-REFUNDABLE AND NON-TRANSFERABLE TO ANOTHER DATE.

## **BOOKING POLICIES**

TO SECURE A DATE, A NON-REFUNDABLE \$200 DEPOSIT IS REQUIRED TO BOOK YOUR DATE. THE DEPOSIT WILL BE APPLIED TOWARD FINAL BALANCE. DUE TO THE POSSIBILITY OF SCHEDULE CONFLICTS, ADDITIONAL MAKEUP AND HAIR ADDED AFTER CONTRACT SIGNING OR CHANGES MADE TO LOCATION AND TIME OF EVENT WILL BE DONE AT THE SOLE DISCRETION OF "MRS.MAKEUP LLC".

## **CANCELLATION POLICY**

IF A CLIENT CANCELS WITHIN 30 DAYS OF THE BOOKED DATE, THEY WILL BE LIABLE TO PAY REMAINDER OF THE SERVICES BOOKED. PAYMENT FINAL PAYMENT FOR BRIDE AND ALL SERVICES BOOKED MUST BE PAID IN FULL BEFORE THE WEDDING AND OR SERVICE FOR THE ENTIRE BRIDAL PARTY. THE BRIDE AND/OR PERSON SIGNING ARE RESPONSIBLE FOR PAYMENT FOR THE ENTIRE BRIDAL PARTY BOOKED. ALL DEPOSITS PAID ARE NON-REFUNDABLE, AND NON-TRANSFERABLE TO ANOTHER DATE (UNLESS DISCUSSED)

ITS IS BEST TO HAVE A TRAIL RUN PRIOR TO WEDDING DAY. P.S NO ONE WANTS FIRST APPOINTMENT. MOST POPULAR QUESTION IS "WILL MY MAKEUP LAST THROUGHOUT THE DAY?". SO I ALWAYS REMIND MY CLIENTS, THAT EVEN IF YOU'RE THE VERY FIRST APPOINTMENT, YOU'LL BE TOUCHED UP AT THE END LOOKING FRESH AS YOU WALK OUT THE DOOR.
